## BLB&G's Catherine van Kampen and Katie Sinderson to Speak at NYCBA's 4th Annual Law Conference on the Status of Women

On March 8, 2023, BLB&G Partner Katie Sinderson and Senior Counsel Catherine van Kampen will speak at the New York City Bar Association's 4th Annual Law Conference on the Status of Women. Furthermore, the panelists will highlight their efforts, and the efforts of their respective organizations, to promote gender equality and empowerment thus far. As a member of the New York City Bar Association's United Nations Committee, she spearheaded organizing the highly successful and widely-praised International Law Conference on the Status of Women, Pro Bono Engagement Fair, EPIQ Women Awards and Huntington Her Hero Awards, featuring the Under Secretary and Special Representative to the Secretary General of the United Nations



for the Prevention of Violence Against Women, and other prominent, progressive women's advocates from the New York Legal Community. In recognition of her work, Catherine was appointed Co-Chair of the New York City Bar Association's United Nations Committee and a Member of the Council for International Affairs in September of 2021.
